Trauma, Loss, and Traumatic Growth: Impact and Intervention with Major Stress and Trauma

Presented by Professor Stevan Hobfoll

Monday 12 & Tuesday 13 March 2007

Stevan Hobfoll is currently Distinguished Professor of Psychology at Kent State University and Director of their Applied Psychology Center and the Summa-KSU Center for the Treatment and Study of Traumatic Stress. He is also a Fellow of the Center for National Security Studies at the University of Haifa, Israel. Formerly at Tel Aviv and Ben Gurion Universities, and an officer in the Israeli Defense Forces, he remains involved with the problem of stress in Israel. Prof Hobfoll was cited by the *Encyclopædia Britannica* for his contribution to knowledge and understanding for his *Ecology of Stress* volume. He was co-chair of the American Psychological Association Commission on Stress and War during Operation Desert Storm, helping plan for the prevention of prolonged distress among military personnel and their families, member of the task force on bioterrorism, and a member of APA's Task Force on Resilience in Response to Terrorism. Prof Stevan Hobfoll has authored and edited 12 books, including *Traumatic Stress*, *The Ecology of Stress*, and *Stress Culture and Community*. In addition, he has authored over 180 journal articles, book chapters, and technical reports, and has been a frequent workshop leader on stress, war, and terrorism. He has received over \$12 million in research grants on stress.

Conservation of Resources (COR) theory has become one of the two leading stress theories. Studies have repeatedly found it to have the strongest predictive value across stress levels. Unlike appraisal based theories, COR theory emphasises the real world interplay of personal, social, condition, and energy resources AND their appraised component. Day 1 will outline the principles of COR theory, methods of assessing resource loss in research and clinical settings, and present research outlining the role of resource loss and gain in settings as diverse as work, schools, disaster, terrorism, and health. The use of cognitive-behavioural techniques to intervene to halt or slow resource loss cycles and enhance resource gain cycles will be detailed. Day 2 will examine the impact and intervention following disaster and terrorism, will look at mass trauma, and will focus on posttraumatic growth.

Learning Outcomes:

1. Understand the principles of Conservation of Resources Theory
2. Understand the central role of resource loss in the stress process
3. Be able to identify key resources and their objective and subjective components
4. Be able to identify and intervene to halt or slow loss cycles following trauma
5. Be able to identify and intervene to enhance resource gain cycles and promote traumatic growth
